

Client Declaration for Trading of Thai Securities

To: KGI Securities Singapore Pte Ltd (“KGI”):

1. Self-Certification of Thai Status

1.1 I/We, the undersigned client(s), hereby certify and declare that: *(please tick applicable box below)*

☐ I am/We are a “Thai Investor”, due to meeting any of the following criteria:

☐ I hold Thai nationality.

☐ We are a corporate body or other entity registered in Thailand.

☐ We are a corporate body or other entity registered outside of Thailand, but one or more of our Ultimate Beneficial Owners* holds Thai nationality and possesses more than 20% of the total shares or voting rights or otherwise exercises ultimate control over the entity.

* Ultimate Beneficial Owner: Any natural person who ultimately owns or controls the Client and/or the person on whose behalf a transaction is being conducted, including those exercising significant or ultimate effective control.

☐ I am/We are not a Thai Investor.

1.2 I/We confirm that all the information provided herein is true and accurate. I/We undertake to immediately advise KGI in writing of any change in circumstances which affects my/our status as a Thai Investor.

2. Declaration, Acknowledgement and Obligation for Thai Securities Transactions

2.1 I/We acknowledge that I am/We are fully aware of, and understand and shall comply with Singapore applicable laws, rules, and regulations, Thai applicable laws, rules, and regulations governing the Thai capital markets, including those issued by the Stock Exchange of Thailand (“SET”), the Securities and Exchange Commission of Thailand (“SEC”), and other relevant authorities.

2.2 I/We understand that Thai Investors are prohibited from purchasing, transferring, or exchanging securities that result in Thai Investors acquiring or increasing possessions of Non-Voting Depository Receipts (“NVDRs”), unless explicitly permitted under Thai law.

2.3 If I am /We are or become a Thai Investor under the criteria set out in Section 1, I/we shall not place any orders or utilize any trading accounts held with KGI to purchase, transfer, exchange, deal in, invest or otherwise acquire any NVDRs.

2.4 I/We understand that, in any circumstances, I/We shall be solely responsible for controlling all trading activities within my/our account. I/We undertake to ensure that no prohibited orders for NVDRs are submitted to the KGI for execution. I/We acknowledge that the KGI acts purely as an executing agent and that I/we shall be solely responsible for my/our own trading decisions. I/We retain all civil,

administrative, and regulatory liabilities for any transactions executed in breach of applicable regulations.

2.5 The execution, settlement, or processing of any transaction by the KGI on the platform shall not be construed as a waiver of these restrictions, an acceptance of the legality of the trade, or a confirmation of regulatory compliance.

2.6 I/We understand that KGI may, at its sole discretion, take any action including but not limited to entering into any forced liquidation of the NVDRs held in Thai Investor's trading account with KGI at my/our own cost and risk, cancelling, limiting or refusing to conduct transaction(s), and suspending, limiting or terminating access to the Thai market entirely, (1) when I/we breach any law, rule, regulation, market requirement or any provision of this declaration as the same may be applicable from time to time (whether such breach is actual or potential), (2) for the purpose of ensuring compliance with or procuring other persons to comply with all applicable laws, rules, and regulations of Thai and Singapore, or (3) for the purpose of avoiding or reducing any losses that the KGI may incur or suffer as a result thereof.

2.7 I/We acknowledge that the KGI might be required to disclose transaction details and the true identity of all ultimate beneficiaries of Thai nationality to upstream executing brokers, custodians, the SET, and the Thai SEC and I/We hereby provide our consent to the KGI for such disclosures.

2.8 I/We acknowledge that I/We shall indemnify and hold harmless KGI in full and upon demand from and against all actions, claims, liabilities, losses, damages, costs and expenses (including without limitation legal fees and costs on a full indemnity basis) whatsoever arising directly or indirectly out of or in connection with any breach of this declaration, any prohibited trading activity (including my/our action of trading NVDRs), or providing false, inaccurate or misleading information regarding my/our status as a Thai Investor.

2.9 This declaration shall be governed by and construed in accordance with, the laws of Singapore. Any disputes arising from or relating to this declaration shall be subject to the jurisdiction of the Singapore courts.
